APPLICATIONS:

Temporary or permanent paper-to-paper applications, hanging light-weight paper to a smooth dry surface, securing photographs in an album, attaching insurance riders/endorsements, temporary sealing of envelopes and cutting/pasting for photocopying.

TECHNICAL NOTES:

1. Test removability before using. Repositionable adhesive may lift some inks, leave a mark on some types of paper and tear some clay-coated, light-weight, specially treated or loose-bond paper.
2. This product is not recommended for displaying photographs or heavy paper objects because paper is dimensionally unstable and tends to move when changes in temperature and humidity occur. #667 is not strong enough to overcome the movement in these items and adhesion failure will occur.
3. Using #667 to secure photographs in an album is a recommended application.
4. Best applications are for paper to paper, or posting light-weight single-sheet paper to smooth dry surfaces.
5. If adhesive transfer should occur upon removal of the tape or separation of papers: To a paper surface - the adhesive can be removed by wiping the area with a dry tissue, or lifted with a soft eraser. To a hard surface - the adhesive can be wiped off with a dry tissue, using 3M #573 Desk and Office Cleaner, or window cleaner with a soft cloth.
